

Privacy Statement SRB Annual Conference 2022: European banks, resolvable and ready for crisis?

1. Data protection legal framework applicable to the SRB

All personal data related to this invitation will be processed in accordance with Regulation (EU) 2018/1725 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data, and repealing Regulation (EC) No 45/2001 and Decision No 1247/2002/EC.

2. Who is responsible for processing your personal data?

The SRB is the data controller determining the purposes and means for processing your personal data. The SRB's Communication Team (<u>SRB-INFO@srb.europa.eu</u>) is responsible for the processing of your personal data

3. Why do we process your personal data?

The purposes of the processing of personal data are the following: management of the conference, including management of lists and mailings-lists for contacts, invitations, participants, reports, distribution of reports, feedback on reports, follow-up meetings, follow-up actions, photographs/pictures, presentations, live web streaming and/or audio and video recording of speakers, news and publications and also to guarantee access to the conference building.

4. Legal bases for processing the personal data:

<u>Article 5(1)(a) and recital 22 of the Regulation (EU) 2018/1725</u>: The lawfulness of the organisation of the event (e.g. registering the event's participants, organisational and administrative activities) is based on Article 5(1)(a) of the Regulation 2018/1725, and in particular on those provisions establishing the SRB and its tasks.

<u>Art, 5 (1)(d) and 7 of the Regulation (EU)</u> 2018/1725 where the processing is based on participants' consent (i.e. taking photos of participants and publishing them on SRB website/ social media channels, video recording, etc.).

Speakers shall consent explicitly to having their photographs/ video recordings taken during the event, and published at the SRB website and/or social media channels. In case consent is not provided by the participants, a photo/film-free zone will be available which the photographers will respect. Speakers can withdraw their consent at any time by contacting the conference organisers at SRB-INFO@srb.europa.eu. Future processing of their personal data will stop once consent is withdrawn, but prior processing will remain lawful.





5. Categories of personal data processed

- Information provided by participants during registration via "EventWorks", such as name, business email address.
- Data necessary for the organisation and management of the meeting, such as gender (needed for the right title)/name/surname/profession/organisation/country of work/e-mail addresses.
- Identity/passport number/date of birth/nationality/passport expiry date (for potential access control purpose by security guards to the meeting premises).
- Pictures, presentations, live web streaming and/or audio and video recording of speakers and participants, (an opt-out is provided upon explicit request for the participants who prefer their images are not recorded).

6. Who has access to your personal data?

When the SRB processes personal data mentioned at part 5 for the purposes mentioned at part 3, the following persons may access your personal data on a strict need-to-know basis:

- Dedicated SRB staff members responsible for the event management from the Communications Team.
- The European Commission's "Event Works" team for purposes of system support and maintenance of the registrations.
- Public, when photos/videos recording are published on the SRB website and/or social media channels.

7. Data retention

Your personal data will be kept as part of our internal contact list at the SRB Communication Team. Should your personal data change please inform us on your part. Otherwise it will be kept for a period of two years.

8. What are your data protection rights?

You have the rights to access your personal data and correct any data that are inaccurate or incomplete. You also have the rights to delete your personal data, restrict or object to the processing of your personal data in line with the relevant provisions of EUDPR. You have the right to withdraw your consent at any time.
